#### PHOTOGRAPHY POLICY

### BASEBALLSOFTBALL UK USE OF PHOTOGRAPHIC AND VIDEO\* IMAGES OF CHILDREN/ YOUNG PEOPLE UNDER THE AGE OF 18

#### POLICY STATEMENT

**BASEBALLSOFTBALL** *UK* is committed to providing a safe environment for children/young people under the age of 18 to participate in sport. Essential to this commitment, is to ensure that all necessary steps are taken to protect children/young people from the inappropriate use of photographic images.

Photographs can be used as a means of identifying children and young people when they are accompanied with personal information. This information can make children vulnerable to an individual who may wish to groom that child for abuse. The content of the photograph can be used or adapted for inappropriate use, there is evidence of adapted material finding its way on to the child pornography site.

**BASEBALLSOFTBALL***UK* will implement this policy with regard to any activity it organises for children/young people.

#### **Key Principles**

- The interests of welfare of children taking part in sport are paramount. Parents/carers and children have a right to decide whether children's images are to be taken and how these images may be used.
- · Images should convey the best images and aspects of sport such as fairness and fun.
- Care should be taken to ensure that images are not sexual or exploitive nor open to misappropriation or misuse.
- Images should only be taken by authorised persons as agreed in the protocol for a
  particular event.
- All images of children should be securely stored.
- In the case of images used on Websites particular care must be taken to ensure that no identifying details facilitate contact with a child by potential abusers.
- · This includes images or recordings via mobile phone.

#### **Publishing Images**

- From the use of consent forms we will ask for the permission of young players and their carers to take and use their image. If a player is named, we will avoid using their photograph. If a photograph is used, we will avoid naming the player directly. We will never publish personal details (e-mail, address, telephone numbers, etc) of a child/young person. Where we pass images to an approved partner for publication, we will require that they follow these guidelines in their use.
- We will only authorise the use of images of players in suitable dress (tracksuits, on field clothing, for example, t-shirts, shorts, skirts) off field clothing.

#### Use of Photographic Filming Equipment of BASEBALLSOFTBALLUK Events and Sessions

- BASEBALLSOFTBALLUK will inform players, parents/carers that photographers may
  be in attendance at an Event/Session and ensure they consent to both the taking of and
  publishing promotional photographs.
- Require parents, spectators and authorised photographers e.g. press to register at an event
  if they wish to use photographic equipment, including mobile phones with photographic
  technology.
- Issue identification pass which must be worn and clearly visible at all times during the
  event.
- Not approve/allow unsupervised access to players or one to one photo sessions at events by any other photographers apart from parents/carers.
- Not allow photographic sessions outside the event or at a player's home.
- Will act on all concerns of any players or parents regarding the inappropriate use of photographic equipment.
- Notify children/young people and their parents/carers if video equipment is to be used as a
  coaching aid or for promotional purposes. Ensure that any photographic images taken and
  used will be stored safely
